## **Director's Report**

The January Director's Report was submitted to the board for review. Mr. Braz shared updates including -

- The library was not awarded a grant in the second round of funding under the NJ Library Construction Bond Act. He and the board's Capital Planning Committee will begin discussing alternative solutions to address the issues and limitations of the current facility.
- Mayor Womack issued an executive order on December 30, 2021 mandating the wearing of masks in all indoor public buildings. The library already requires mask usage for all staff and patrons who enter the library building.
- The library treated the employees to staff meals. The staff meals were an alternative to a staff holiday party that have not been held for the past two years due to the pandemic.
- The library building was closed to the staff and the public from January 8 through January 15. The building closure was caused by staff members testing positive for COVID and several others were out sick or isolating. This resulted in not enough available staff to safely open the building. During the closure, the library did not decrease the number of hours available to the public, and Mr. Braz and Ms. Anna Shifton, Senior Librarian, handled the daily operations and services that could be available to the public during the building closure (e.g., contactless pick-up, printing, photocopying, etc.).

NJ Library Construction Bond Act

- Ms. Paccillo shared that the library did not receive an award in the second round of funding. She has informed the mayor of the result. She has obtained the OPRA (Open Public Records Act) documents of the state's review of the library's grant application, and has a meeting scheduled on 1/20/2022 with the NJ State Librarian to understand the review and decision process for the second round; Mr. Braz and Ms. Braccino will also participate in that meeting.
- Mr. Braz shared that he contacted Anthony Iovino, the architect, and Mr. Iovino offered to review past plans of expansion options for the library. As Mr. Braz indicated in his Director's Report, he and the board's Capital Planning Committee will be reviewing alternative solutions to address the issues and limitations of the current facility.
- The board agreed to change the New Building Committee name to Capital Planning Committee.
